#### **CALL TO ORDER**

# A. Minutes from the OCFA Foundation Board of Directors Special Meeting held on November 15, 2024

Recommended Action: Approve as submitted.

#### 2. NEW BUSINESS

#### A. Update on Amendments to the OCFA Foundation Bylaws and Transition Plan

Wendy Moore, Consultant, provided an update on recent developments following the approval of the OCFA Foundation Bylaws. She reported that work is currently underway to establish procedures across various operational areas. In addition, efforts are in progress to appoint a new Secretary and Treasurer, as well as three new Board Members representing Southern California Gas Company, AT&T, and Rubegero and Associates. Outreach is also being conducted to potential partners, including Southern California Edison and the Irvine Company.

Ms. Moore noted that the Foundation is developing a new, standalone website, independent of the OCFA's main site. Additional considerations include the acquisition of a dedicated phone number, updated insurance coverage, scheduling of a Board retreat, implementing quarterly meetings, and planning for a potential 15th anniversary celebration, which may coincide with a rebranding effort for the Foundation.

#### **B. EXP Summer Internship Program**

Assistant Chief and Human Resources Director Stephanie Holloman presented an overview of the EXP High School Internship Program, a partnership between EXP and local high schools that prepares students for career opportunities through hands-on work experience. The program delivers a career-based curriculum and conducts seven work-readiness workshops each spring, covering resume writing, interview skills, career exploration, financial literacy, and more. Since its inception in 2003, EXP has placed over 1,000 students in paid internships, reporting a 99% graduation rate among participants and strong indications of post-secondary interest.

The program is expanding in Orange County, now including five additional high schools. At OCFA, EXP internships focus on non-safety roles, helping build a pipeline for administrative and support services critical to agency operations. Benefits extend to both interns and employers, fostering innovation, mutual learning, and community engagement. Despite some barriers, such as scheduling and lack of a structured training environment, the program supports OCFA's recruitment and outreach goals.

On motion of Vice Chair Lowe, and seconded by Director Hernandez, the Board unanimously approved the funding request of \$19,200 and the request for an annual report card on the EXP Internship Program to be presented next year.

### C. Financial Update on Foundation Administration

Jim Ruane, Chief Financial Officer, presented a request for a motion to approve funding of up to \$60,000 to cover expenses for the 17th Annual Best and Bravest event. The motion was made by Director Hernandez, seconded by Vice Chair Lowe, and was approved unanimously.

Mr. Ruane also informed the Board that the Foundation has engaged OBM, a new bookkeeping and accounting firm, to handle payment processing until July 1, or until another firm is contracted.

Additionally, Mr. Ruane requested a motion to expand the Fire Cadet Program to include an annual internship program and to provide t-shirts and uniform wear for participants. He confirmed that funding is available for the expansion. The motion was made by Director Butterfield, seconded by Director Hernandez, and was approved by unanimous consent.

#### **Summary**:

This agenda item is submitted to provide authorization to the Foundation Chief Financial Officer (CFO) to transfer donation funds received from G&M Oil to programs *Fire Stations - Seal Beach* (44/48) and *Fire Stations - Westminster* (64/65/66).

#### **Recommended Action:**

Authorize the Foundation CFO or his designee to transfer \$20,000 in donation funds received from G&M Oil to programs *Fire Stations - Seal Beach (44/48)* and *Fire Stations - Westminster (64/65/66)*.

#### Fiscal Impact:

None (inter-program transfer only)

#### Background:

In May 2025, the Foundation received a \$20,000 donation from G&M Oil with instructions that the funds be designated as \$10,000 for the Seal Beach fire stations (44/48) and \$10,000 for the Westminster fire stations (64/65/66). However, the donation was recorded by the Foundation as a general-purpose (undesignated) donation.

Since the donation was received and recorded in a prior (and closed) fiscal year—FY 2023/24—Board authorization is requested to re-designate the donation to the intended programs in the current/open fiscal year, FY 2024/25, via an inter-program transfer. This transaction will ensure that the future use of these donated funds are utilized exclusively for the donor's designated purpose.

#### Summary:

This agenda item is submitted to recommend Board of Directors approval of two grants submitted by the Orange County Fire Authority (OCFA) for support of the 2025 Fire Cadet Academy and the 2025 Girls Empowerment Camp. In addition, staff recommends that the Board authorize the Foundation Chief Executive Officer (CEO), or his / her designee, to award future grants applied for by the OCFA in order to implement Foundation programs as established by the Foundation Board of Directors, subject to certain conditions and restrictions.

#### Recommended Action(s):

- 1. Authorize the Foundation Chief Financial Officer (CFO) or his designee to issue a grant to the OCFA in the amount of \$60,000 in support of the 2025 Fire Cadet Academy, and \$90,000 in support of the 2025 Girls Empowerment Camp.
- 2. Authorize the Foundation Chief Financial Officer (CFO) or his designee to transfer funds from General / Unrestricted balance to the Fire Cadet Academy and Girls Empowerment Camp as needed to cover the cost of the grants.
- 3. Authorize the Foundation Chief Executive Officer (CEO) to award future grants applied for by the OCFA for the purpose of implementing Foundation programs as established by the Foundation Board of Directors, subject to funding availability and the CEO or his / her designee's determination of eligible expenditures.

#### Background:

As directed by the Board of Directors, effective July 1, 2025, the remaining executive management and administrative functions of the Foundation will no longer be performed by OCFA staff, including the disbursement of Foundation funds. Establishing a grant program will provide a mechanism for the disbursement of Foundation funds for the purpose of providing financial support for Board-approved events and programs implemented by the OCFA or other entities.

The recommended grants are to be issued on a lump-sum, advance payment basis. The grantee is responsible for returning to the Foundation any advanced grant funds in excess of actual costs incurred in implementing the applicable program or event, within 90 days of the program or event's conclusion. Eligibility of expenditures and acceptance of corresponding documentation (e.g., detail vendor invoices) are subject to approval by the Foundation CEO or his / her designee.

#### Fiscal Impact:

Sufficient funds are available in the corresponding program balances and through transfers from the Foundation General / Undesignated program balance for disbursement of the following grants:

- 2025 Fire Cadet Academy not to exceed \$60,000
- 2025 Girls Empowerment Camp not to exceed \$90,000
