VOLUNTARY RELEASE OF LIABILITY AND INDEMNITY AGREEMENT FOR INSTALLATION OF CHILD SAFETY SEAT

I, _____ (Print Name) do hereby request and consent that an employee of the Orange County Fire Authority ("OCFA") install a child safety seat in my vehicle - _____ (year, make, & model of vehicle), and provide guidance to me regarding the installation of the child safety seat in my vehicle. I understand and agree that the purpose of this installation and guidance by OCFA is to reduce the incidents of improper installation of child safety seats and that this installation and guidance by OCFA cannot fully evaluate the quality, safety or condition of the child safety seat or any component of my vehicle, including but not limited to, the seats or the safety belts.

In consideration of OCFA's installation of the child safety seat and guidance to me regarding the installation of the child safety seat in my vehicle, I, for myself, my personal representatives, heirs, next of kin, spouse and assigns, DO HEREBY

1. RELEASE, DISCHARGE, AND AGREE NOT TO SUE the OCFA, its elected and appointed officials, officers, employees, agents, and volunteers (collectively "Indemnities") from any and all claims and liability arising out of strict liability or ordinary negligence which causes any harm, injury, or damage which may be sustained, incurred, or suffered whether foreseen or unforeseen, arising from or connected in any way to OCFA's installation of the child safety seat in my vehicle, or OCFA's guidance to me regarding the installation of the child safety seat in my vehicle, or my use of the child safety seat.

2. AGREE to hold the Indemnitees harmless and indemnify them from any claim, loss, demand, judgment or expense they may incur arising from or connected in any way to OCFA's installation of the child safety seat in my vehicle, or OCFA's guidance to me regarding the installation of the child safety seat in my vehicle, or my use of the child safety seat.

3. UNDERSTAND that OCFA's installation of the child safety seat in my vehicle, or OCFA's guidance to me regarding the installation of the child safety seat in my vehicle, cannot guarantee my child's safety or any other person's safety in a vehicle collision or while riding in a vehicle.

4. UNDERSTAND that to have the protective benefit of a child safety seat, I must install the child safety seat and secure my child in the child safety seat properly according to the instructions by the child safety seat manufacturer.

I have read this document. I understand it is a release of all claims. I voluntarily sign my name evidencing my acceptance of the above provisions.
